**Notification inviting applications on-line for Admission into MBBS and BDS
Courses for the academic year 2019-20 in colleges in the state of Telangana
affiliated to KNRUHS, Warangal for competent authority quota.**

Application forms are invited online from candidates who have qualified by securing the following cutoff scores and above in National Eligibility-cum- Entrance Test (NEET) UG – 2019 and fulfilled the following eligibility criteria for admission into Under Graduate Medical and Dental Courses for the academic year 2019-20 under Competent Authority Quota in Government, Private Medical & Dental Colleges affiliated to KNRUHS, Warangal.

This notification is only for determining State Merit position for admission into Competent Authority Quota seats i.e., the seats in Government Medical / Dental Colleges after contributing 15% of seats to All India Quota and Category 'A' seats in Private Un-aided Non-Minority and Minority Medical colleges, Private Un-aided Non-Minority Dental Colleges including Army Dental College, Hyderabad. Total number of seats under competent authority quota along with seat-matrix for the academic year 2019-20 will be notified on KNRUHS website prior to counseling. Fee structure is as fixed by the Government.

Minimum Qualifying Score in NEET UG - 2019:

Category	Qualifying Criteria	Cut off score (out of 720)
General category including EWS	50 th Percentile	134
SC/ST/BC & PWD Candidates of SC/ST/BC Category.	40 th Percentile	107
Persons with Disability (OC)	45 th Percentile	120

Provisional State Merit position of the candidates applied for, will be prepared based on the NEET UG – 2019 Ranks and other eligibility criteria notified hereunder. Final Merit list will be prepared after verification of Original Certificates of applied candidates.

I. **ELIGIBILITY:** The Eligible candidates, who have qualified and secured marks of minimum percentile and above in NEET UG – 2019, have to apply for determining the State Merit position for Competent Authority quota seats subject to the conditions specified in admission Regulations/Prospectus. (Refer regulations/ prospectus for detailed clarifications).

- a) The candidate should be an Indian National or Person of Indian Origin (PIO) / Overseas Citizens of India (OCI) Card Holder and should satisfy the Local or Non- local status in

Telangana State as laid down in Andhra Pradesh Education Institutions (Regulations of Admissions) Order, 1974. Selection will be done as per the procedure laid down in the G.O.P.No. 646, dated 10.07.1979 as amended in G.O.Ms.No.42, Higher Education (EC2) Department, dated 18.05.2009 and G.O.Ms.No. 114 HM&FW(C1) Dept. Dated: 5-7-2017 and subsequent amendments.

- b) The candidate should have passed Intermediate (10+2 pattern) or its equivalent examination with Physics, Chemistry, Biology (Botany, Zoology) / Biotechnology and English.
 - i. OC candidates should obtain not less than 50% marks in science subjects.
 - ii. BC/SC/ST candidates should obtain not less than 40% marks in science subjects.
 - iii. OC PH candidates should obtain not less than 45% marks in science subjects.
 - iv. Candidates claiming reservation under EWS category also should obtain 50% marks in science subjects.
- c. The candidate should have qualified in NEET UG -2019 conducted by CBSE, New Delhi.
- d. The candidate should have completed 17 years of age as on 31-12-2019. The candidates who do not complete 17 years as on 31-12-2019 need not attend the counseling. The candidates born on or after 02-01-2003 are not eligible for admission into MBBS/BDS Courses.
- e. The candidates who wish to claim seats under Anglo Indian, CAP (Army), NCC, Persons With Disability (PWD) and Police Martyrs Children (PMC) also need to fulfill the above eligibility criteria.
- f. Candidates who want to claim reservations under Persons With Disability (PWD) quota shall appear for evaluation of their disability status before Medical Board constituted for the purpose by the University as per the schedule to be notified on website.
- g. In obedience to the orders of Hon'ble High Court WP.No. 22700/2018 there will not be any admissions under Sports Category for academic year 2019-20.
2. The candidates are advised to download and read the Prospectus/Regulations available in the website www.knruhs.in & <http://www.knruhs.telangana.gov.in/> before filling the Online application form for admission into MBBS & BDS Courses for the academic year 2019-20.
3. The qualified and eligible candidates as per the regulations who desire to take admission in to UG Medical and Dental Courses in Government, Private Un-aided Non-minority & Minority Medical colleges & Govt. Dental College and Private Non-Minority Dental Colleges including Army dental College shall apply online for determining the State Merit position for Competent Authority quota seats in respective categories in the Website <https://tsmedadm.tsche.in> from 8.00 AM on 22-06-2019 to 28-06-2019 upto 4.00 p.m only. The online application can be filled through any computer with internet connection (home/internet café/net center) with Internet Explorer - 11 Version.
4. Registration and Verification Fee for UG Medical and Dental Courses :- The Registration and Verification fee Rs.3,500/-(Bank transaction charges extra)for OC & BC candidates and Rs.2,900/- (Bank transaction charges extra) for SC/ST candidates. Fee shall be paid through online by Debit card / Credit card or Net Banking.**

****Under any circumstances fee once paid will not be refunded or adjusted to a further date.**

5. Procedure of filling online application and online payment for MBBS and BDS Courses

- a. Read the Notification, Prospectus / Regulations carefully
- b. Visit website through Internet Explorer 11 version only to fill the application form
- c. The fee can be paid through Debit card / Credit card or Net Banking
- d. The fee paid by the applicants is not refundable/transferrable under any circumstances.
- e. **Registration number sent to the registered mobile after entering the basic data should be noted for further use. The Registration number should be kept confidential and not to be disclosed to others.**

6. The following documents must be ready while filling online application to avoid delay in filling:

- a. Admit card of NEET UG - 2019
- b. Rank card of NEET UG-2019
- c. SSC or equivalent examination containing the Date of Birth
- d. Memorandum of marks of qualifying examination i.e., Intermediate or Equivalent examination.
- e. Transfer certificate (T.C)
- f. Study Certificate(s) from 6th class to Intermediate.
- g. Latest Permanent Caste certificate issued by the competent authority of Govt. of Telangana
Minority status certificates if applicable.
- h. Aadhar Card
- i. In case of candidates studied in the institutions outside the state residence certificate of the candidate or either parent issued by MRO / Tahasildar of Telangana/AP for a period of ten - years (Period to be specified with exact month and year) excluding the period of study/employment out-side the state.
- j. Special Category Certificates (NCC, PMC, CAP).
- k. EWS certificate issued by the competent authority of Govt. of Telangana (Tahasildar) if applicable.

7. Procedure for submission of filled-in online Application form for MBBS and BDS courses:-

The candidate should submit the print-out of the filled-in Online application form in person along with two (2) sets of self attested copies of required certificates on the scheduled date at the specified center for verification of original certificates to be notified by the University. The candidates need not submit Printout of Application by post/by hand to the University.

8. The original certificates to be submitted for verification at the time of verification of original certificates at the notified center.

(a) Admit card of NEET UG - 2019

(b) Rank card of NEET UG-2019

(c) SSC or equivalent examination containing the Date of Birth

(d)Memorandum of marks of qualifying examination i.e., Intermediate or Equivalent examination.

(e)Transfer certificate (T.C)

(f)Study Certificate(s) from 6th class to Intermediate.

(g)Latest Permanent Caste Certificate (Integrated Community Certificate) issued by the competent authority. Candidates claiming local candidate status should submit caste certificate issued by specified authority of Telangana Government.

(a) Service records of parent or SSC/ SSLC certificate of parent if parent is not in-service.

(h)Aadhar Card

(i)Minority status certificates issued by the concerned Department.

(j)Candidates who have studied in the institutions outside of Telangana have to submit 10 years (years of period to be specified) residence certificate of the candidate or either of the parent issued by MRO / Tahsildar of Government of Telangana.

(k)The candidates claiming fee exemption shall produce the latest Income certificate of the Parent issued by MRO / Tahsildar of Government of Telangana.

(l)Undertaking in the form of Affidavit on Rs. 100 /- Stamp paper by the Parent and candidate stating that the caste and area mentioned in the certificates are genuine and they will be held responsible for any further consequences as per law, if any discrepancy is noticed at a later date.

(m)Candidates claiming eligibility of reservation under Special categories i.e., CAP, NCC, PMC and Anglo Indian should furnish the required original certificate in support of their claim.

(n) Candidates claiming eligibility of reservation under EWS should furnish the required original certificate in support of their claim issued by competent authority of Government of Telangana.

Note:

1. Application form without Passport size photo, without signature at declaration area and incomplete applications at the time of verification of original certificates will stand automatically rejected and will not be considered for determining the State Merit position in respective categories.

2. Candidates inclusion in merit list and admission is strictly provisional. The mere fact that the Merit position is issued to him/her does not imply that his/her candidature is accepted by the University and it does not mean that the entries made by him/her in the online application are accepted as true and correct. He/she may please note that the University will take up the verification of original certificates with regard to eligibility conditions i.e., NEET UG-2019 Rank, educational qualifications, local/non local area status, category etc., after duly verifying all the relevant certificates at the time of verification of original certificates .

If the information furnished by the candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deems fit will be taken.

3. Mere submission of application through Online is not sufficient. Candidates eligibility for admission into MBBS/BDS Courses for the academic year 2019-20 will be examined by the University only after submission of printout of on-line application (hard copy) along with 2-sets of all enclosures specified at the notified helpline centers for verification of original certificates.

4. The Orders issued from time to time by Ministry of Health & Family Welfare, Telangana State Government, Government of India, Medical Council of India, Dental Council of India, Hon'ble High Court and Supreme Court with regard to Admission into Medical and Dental Courses shall apply.

5. This notification is for determining the State Merit position only.

The notification for exercising web options for admission to MBBS/BDS courses and procedure will be notified separately on the University web-site from time to time. Candidates, parents are informed to refer to the University web-site for updates for the schedule of the counseling, and other information. No individual communication will be sent.

6. An in-eligible candidate obtaining Merit position does not make him/her eligible for admission.

7. Admission will be given only for candidates, who have secured marks of minimum cutoff score and above prescribed for that category in NEET – UG – 2019 and after fulfilling the eligibility conditions.
